## Pacific Orientation to Responsibility

## Reciprocity

Water shares a genealogy with land who in turn shares a genealogy with man, the cosmos and the gods. This genealogy is sacred and invests a legacy of responsibility on all living things (trees, clouds, volcanoes, water, animals, people) to respect through reciprocity, the divine balance or harmony they share. This is what Samoans call the vatapuia – the sacred relations. H.H. Tui Atua Tupua Tamasese Efi

### Leadership

Power/wisdom is acquired through working with others and working the land. For instance Logovae refers to power as 'both a gift and a burden' and adds that 'while it is a privilege, responsibilities are its constant companion

## Water Matters

New Zealand lowland freshwater is in a degraded state.

- Challenges in Water Governance
  - Water quality
  - Dairy farming
  - Maori interests. Iwi own river beds and the Crown governs water columns - a system of fragmented governance.
  - RMA

## Water Interest in Aotearoa NZ

 Vesting of water as a 'person' in law, as in Whanganui and Te Urewera

 Sale of hydro State assets activates Māori claim for recognition of Māori interests in fresh water, on basis that sales cannot proceed until Maori interests are settled.

 A new approach based on shared responsibility for the ecological integrity of water, working with a legal framework of trusteeship

## **Respons-ability**

Speaks to governance and decision-making

 A framework for integration of social, environment and economy for development of a green economy (which addresses poverty).

 Responsibility is the foundation of community provides for accountability and responsiveness

 Counterpoint to rights and addresses implementation side of rights


# Rationale for Respons-ability

 Globalized world creates interdependence and common human destiny – can Responsibility be a guiding ethic for common wellbeing?

 Could Respons-ability provide a framework for transcending sovereign (state) for human and planetary benefit?

 Respons-ability – accountable and responsive dimensions of transitions to sustainable societies.

## Quantum Matter and Respons-ability

 Difference is never discrete or absolute – it arises out of 'entanglement'

• 'Phenomena' (identities ) emerge out of intra-actions

 We are responsible because we are part of others from which we take form

 Hospitality – expression of relationality and putting an Other before self interest – water to drink and food entangles us in waterways and land and systems of food production

## Historical Momentum for Respons-ability

- The Universal Declaration of Human Rights 1943 provided platform for the development of law and implementation which evolved over following decades.
- Proposal for a charter for Universal Responsibilities -History examples:
  - Unanimous Declaration of Interdependence 1969
  - Universal Declaration of Interdependence 2002
  - Treaty on Environmental Education for Sustainable Societies & Global Responsibility 1992
  - Universal Declaration of Human Responsibilities 1997/1998
  - Youth Charter of Responsibilities 'Lets Take Care of the Planet' 2010
  - Caux round table principles for Corporate Business 1992
  - World Charter for Nature 1982
  - Earth Charter
  - Universal Declaration of Rights of Mother Earth 2010

# Respons-Ability

- Unprecedented challenge of prospective responsibility
- Intergenerational accountability
- Responsibility proportionate to power
- Relational ethic and basis for collaboration
- Aligned with indigenous systems of integrated decision-making and aspirations for kaitiakitanga, manaakitanga and sustainability

#### A CHARTER OF UNIVERSAL RESPONSIBILITIES

### Preamble :

We acknowledge that the scope and irreversibility of the <u>interdependencies</u> among human beings, among societies, and between humankind and the biosphere, creating it into <u>a community of destiny</u>.

We affirm that global interdependencies require recognition of <u>common though</u> differentiated responsibilities and accountability at international and State levels.

### Article

We recognize that the fundamental problem underlying the present environmental, economic, financial and social crises is the absence of an unequivocal international agreement on common though differentiated responsibilities that could serve as a regulatory framework for future international law.

A Charter of Universal Responsibilities as a necessary complement to the Charter of the United Nations and the Universal Declaration of Human Rights.

### Article

We acknowledge the responsibility of the private sector in the promotion of sustainable development. This responsibility goes together with accountability not only to their own constituency, but to the larger global community as well. A Charter of Universal Responsibilities would create the basis for future international law pertaining to responsibilities and accountability of the private sector.
